FROM THE CHAIR

I have received official notice from the Maryland State Administrative Board of Election Laws that our Presidential team of Andre Marrou and Nancy Lord will be on the ballot! Thanks to all whose hard work have made this a reality, and thanks to our ten electors who have promised to cast their votes in the Electoral College in the event that Andre and Nancy carry Maryland in November.

The growth of the Libertarian Party in Maryland continues at a breathtaking pace. We now have 1003 registered Libertarians in the state. Our mailing list is rapidly approaching the 3000 mark. An appearance by Andre Marrou on the G. Gordon Liddy radio program last month generated 71 new inquiries IN MARYLAND ALONE!

As you might expect, our last Executive Board meeting was a busy one, seeking ways to effectively use that new

growth. We still have a long way to go before the state will let our other candidates' names appear on the ballot. We must begin to take aim at the 1994 elections and plan to run as complete a slate of State Legislative candidates as possible.

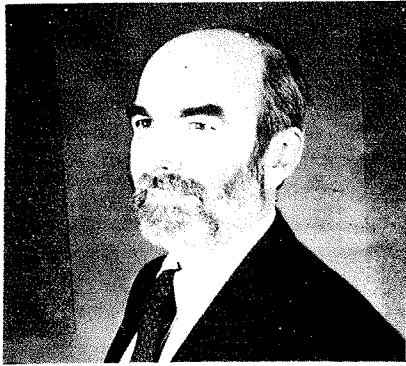
Two necessary steps are to (1) get as many of the new prospects to become members and registered Libertarians as possible; (2) to bootstrap from our present support to expand the registration drive and get more people registered Libertarian. To have 10,000 registered libertarians by the time of the election is extremely difficult, but not impossible. We are going to try. You can do your part by asking everybody you know to register Libertarian. Now that the primaries are over, they sacrifice nothing by doing so. The impact of the rapid growth of the Party on our credibility must not

be underestimated.

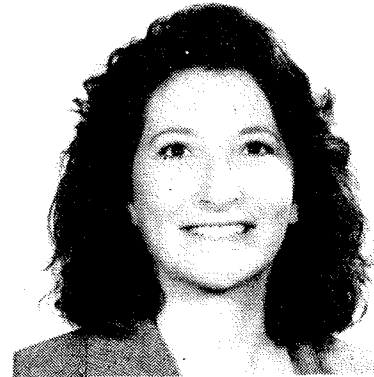
